END USER LICENSE AGREEMENT

(The "EULA")

PLEASE READ THIS END USER LICENSE AGREEMENT CAREFULLY, AS IT CONSTITUTES A **CONTRACT BETWEEN BINDING** RETRO MODDING INC. AND YOU AND GOVERNS YOUR USE OF THE VIDEOGAME, APPLICATION, SOFTWARE, THEIR ASSOCIATED UPGRADES, PATCHES. **AND UPDATES** AND RELATED SERVICES (THE "GAME") CURRENTLY PROVIDED OR WHICH WILL BE PROVIDED BY RETRO MODDING INC. DOING BUSINESS AS INCUBE8 GAMES, OR ANY OF ITS SUBSIDIAIRES OR **AFFILIATED COMPANIES** (COLLECTIVELY REFERRED TO AS "INCUBE8 GAMES").

This EULA sets out the basis on which Incube8 Games makes the Game available to you ("User" or "you") and on which you may use it. By installing or using the Game, you agree to accept and be bound by this EULA at all tine. If you do not agree with this EULA, please do not install or use the Game.

Incube8 Games reserves the right, in its sole and absolute discretion, to change, modify, add or delete articles in this EULA at any time, in accordance with the procedures described below in Section 5.

1. GRANT OF LICENSE

- 1.1. License. Incube8 Games (or its licensors) grants you a non-exclusive, non-transferable, non-sublicensed, non-commercial and personal license to install and/or use the Game (in whole or in part) and any Game (the "License"), for such time until either you or Incube8 Games terminates this EULA. You must in no event use, nor allow others to use the Game or this License for commercial purposes without obtaining a license to do so from Incube8 Games. Updates, upgrades, patches and modifications may be necessary in order to be able to continue to use the Game on certain hardware. THIS GAME IS LICENSED TO YOU, NOT SOLD.
- 1.2. **Limitations.** You shall not, directly or indirectly (i) sell, rent out, lease, license, distribute, market, exploit the Game or any of its parts commercially, (ii) reverse engineer, decompile, disassemble, adapt, reproduce, or create derivative works of this Game (except if specifically allowed by the Game), in whole or in part; (iii) create, use and/or distribute "auto", "trainer", "script" or "macro" computer programs or other "cheat" or "hack" programs or software applications for this Game; (iv) remove, alter, disable or circumvent any copyright and trademark indications or other authorship and origin information, notices or labels contained on or within this Game and (v) export or re-export this Game or any copy of adaptation in violation of any applicable laws or regulations.

- 1.3. **Applicable laws.** While using the Game, you agree to comply will all applicable laws, rules and regulations. In all cases, you may only use the Game according to anticipated use of the Game.
- Prohibited actions. Without limiting the foregoing 1.4. and Incube8 Games's rights to take action against you, you may not (i) create, use, share and/or publish by any means in relation to the Game any material (text, words, images, sounds, videos, etc.) which would breach of a duty of confidentiality, infringe any intellectual property right or which would incite the committing of an unlawful act (in particular, piracy, cracking or circulation of counterfeit software); (ii) modify, distort, block, disrupt and/or hinder the normal functioning of all or part of the Game; (iii) create, supply or use alternative methods of using the Games; (iv) falsely claim to be an employee or representative of Incube8 Games or its partners and/or agents: (v) falsely claim an endorsement in connection with the Game or with Incube8 Games.

2. OWNERSHIP

All title, ownership rights and intellectual property rights in and to the Game (including, without limitation, all text, graphics, music or sounds, all messages or items of information, fictional characters, names, themes, objects, scenery, costumes, effects, dialogues, slogans, places, characters, diagrams, concepts, choreographies, videos, audio-visual effects, domain names and any other elements which are part of the Game, individually or in combination) and any and all copies thereof are owned by Incube8 Games or its licensors. The Game is protected by national and international laws, copyright treaties and conventions and other laws. This Game may contain certain licensed materials and, in that event, Incube8 Games's licensors may protect their rights in the event of any violation of this EULA. Any reproduction or representation of these licensed materials in any way and for any reason is prohibited without Incube8 Games's prior permission and, if applicable, Incube8 Games's licensors' and representatives'. Except as expressly set forth in this EULA, all rights not granted hereunder to you are expressly reserved by Incube8 Games. This License confers no title or ownership in the Game and should not be construed as a sale of any rights in the Game.

3. WARRANTY DISCLAIMER AND LIMITATION OF LIABILITY

3.1. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, YOU EXPRESSLY ACKNOWLEDGE THAT YOUR USE OF THE GAME IS AT YOUR OWN RISK. To the fullest extent permissible under applicable law, the Game is supplied on an "AS IS" and "AS AVAILABLE" basis. Incube8 Games and Incube8 Games's licensors do not make and hereby disclaim any guarantees, conditions, warranties of any kind, express, implied or statutory or other terms including as to: (a) its conformity, accuracy, currentness, completeness, reliability

or security (b) its suitability for a particular use; (c) implied warranties of title, non-infringement; (d) its market value; or (e) your satisfaction. Incube8 Games does not warrant that the Game will be error-free, that defects will be corrected, or that the Game is free of viruses or other harmful components. You assume all responsibility for selecting the Game to achieve your intended results, and for the installation of, use of, and results obtained from the Game.

- 3.2. To the fullest extent permissible under applicable law, in no event will Incube8 Games and Incube8 Games's licensors be liable for loss or damage suffered in connection with the use of the Game or any related third party service. This includes without limitation (a) all losses of any kind, whether in tort (including for negligence or breach of statutory duty), contract, misrepresentation (whether innocent or negligent) or otherwise, (b) direct loss; (c) accidental loss, (d) incidental loss, (e) consequential loss, and (f) indirect loss.
- 3.3. Notwithstanding the aforementioned limitations of liability, your sole remedy in the event of a dispute with Incube8 Games or its licensors is to cease to use the Game; and if applicable, seek damages for your losses. For any Game purchased for use on a compatible terminal that would not meet the applicable legal warranties, Incube8 Games's liability is limited to the refund (directly or indirectly through the relevant service providers) of the purchase price of the Game. - 3.5. For purposes of this section 3, Incube8 Games's licensors are third party beneficiaries to the limitations of liability specified herein and they may enforce this EULA against you.

4. INDEMNITY

- 4.1. You are solely responsible for any damage caused to Incube8 Games, its licensors, and subcontractors, other users of the Game or any other individual or legal entity as a result of Your violation of this EULA.
- 4.2. You hereby agree to defend, indemnify and keep indemnified Incube8 Games and its affiliates, their licensors, and associated service providers and their subcontractors against any claim or alleged claims, liabilities, losses damages and all costs (including lawyers' fees), directly or indirectly attributable to your fault and/or resulting from (a) a violation of any provision of this EULA or (b) your use or misuse of the Game. Incube8 Games reserves the right to take sole responsibility, at its own expense, for conducting the defence of any claim for which you agreed to indemnify

Incube8 Games. The provisions of this Section 4 shall remain in force after the termination of this EULA.

5. TERMINATION

The EULA is effective from the earlier of the date you purchase, download or use the Game, until terminated according to its terms. You and Incube8 Games (or its licensors) may terminate this EULA, at any time, for any reason. Termination by Incube8 Games will be effective upon (a) notice to you or (b) at the time of Incube8 Games's decision to permanently discontinue offering and/or supporting the Game, which it may do at any time in its sole discretion. This EULA will terminate automatically if you fail to comply with any of the terms and conditions of this EULA. Upon termination for any reason, you must immediately uninstall the Game and destroy all copies of the Game in your possession.

6. CHANGES TO THE EULA

Incube8 Games reserves the right, in its sole and absolute discretion, to revise, update, change, modify, add to, supplement, or delete certain terms of this EULA for security, legal, best practice or regulatory reasons. Such changes will be effective with or, as applicable, without prior notice to you. You can review the most current version of this EULA by visiting the webpage "EULA" available on Incube8 Games's website. You are responsible for checking this EULA periodically for changes. If any future changes to this EULA are unacceptable to you or cause you to no longer be in agreement or compliance with this EULA, you may terminate this EULA in accordance with Section 5 and must immediately uninstall the Game and destroy all copies of the Game. Your continued use of the Game following any revision to this EULA constitutes your complete and irrevocable acceptance of any and all such changes.

7. CHANGES TO THE GAME

Incube8 Games may modify the Game for any reason or without any specific reason, at any time and at its entire discretion, in particular for technical reasons such as updates to improve and/or optimize the Game. You agree that Incube8 Games may stop to support previous versions of the Game upon availability of an updated version.

8. GENERAL

- 8.1. **Severability**. If a particular provision of this EULA is held to be invalid or unenforceable by a court of competent jurisdiction, the provision shall be interpreted in a manner consistent with applicable law to reflect, as nearly as possible, the original intention of Incube8 Games shall not otherwise affect the validity and enforceability of this EULA or any other part thereof.
- 8.2. **Assignment**. Incube8 Games may assign this EULA, in whole or in part, to any person or entity at any time with or without your consent. You may not assign this

EULA without Incube8 Games's prior written consent, and any unauthorized assignment by you shall be null and void.

- 8.3. **No Waiver**. Incube8 Games's failure (or its licensors) to exercise or delay in exercising any right, power or privilege under this EULA shall not operate as a waiver. No single or partial exercise or waiver of any right, power or privilege shall preclude any other or further exercise thereof. Any waiver of any provision of this EULA shall only be deemed to have been made if expressed in writing by Incube8 Games (or its licensors) granting the waiver.
- 8.4. **Force Majeure.** Incube8 Games shall not be liable for any delay or failure to perform resulting from causes outside the reasonable control of Incube8 Games, including, without limitation, any failure to perform hereunder due to unforeseen circumstances or cause beyond Incube8 Games's control such as acts of god, war, terrorism, riots, embargoes, acts of civil or military authorities, fire, floods, accidents, strikes, or shortages of transportation facilities, fuel, energy, labour or materials.
- 8.5. **Export controls**. The Game is subject to all applicable export restrictions. You must comply with all applicable export and import laws and restrictions and regulations of any jurisdictions, agency or authority relating to the Game and Your use of the Game. You represent and warrant that you are complying with all applicable export and import restrictions and are not in breach of said applicable export and import restrictions.
- 8.6. **Governing Law and Jurisdiction**. This EULA shall be construed and governed in accordance with the laws of the Province of Québec and the laws of Canada applicable therein, without regard to principles of conflicts of law, or the *Vienna Convention on the International Sale of Goods*. The parties hereby irrevocably attorn to the exclusive jurisdiction of the courts sitting in the Province of Québec, the judicial district of Montreal. Those who install, use or

access the Game from locations outside of Canada do so on their own initiative and are responsible for compliance with local laws if and to the extent local laws are applicable. Should a court of competent jurisdiction determine that other laws apply, this EULA shall be enforced to the fullest extent permitted by the laws of the applicable jurisdiction and be interpreted to give maximum effect to the terms and conditions hereof

8.7. **Entire Agreement**. This EULA and any schedules attached hereto constitutes the entire understanding between Incube8 Games and you relating to your rights and obligations in the use of the Game. If there is a conflict between this EULA and any other terms of Incube8 Games, Incube8 Games shall resolve the conflict in its sole discretion.
